- (1) The officers and employees will be treated as on duty during the period of the training including transit period.
- (2) All expenses in this connection will be borne from the annual budget allocation of the Fire Service and Civil Defence Department.
- (3) The officers and employees will draw their usual pay and allowances from Bangladesh in local currency. No part of it shall be drawn in foreign currency.
- (4) They will leave Dhaka for Malaysia on 20/5/2017 or nearest suitable date and will leave Malaysia for Dhaka on 05/6/2017 or nearest suitable date.

03. They will submit a report on the training programme to the Security Services Division, Ministry of Home Affairs within seven days of their return.
