- (4) They will leave Dhaka for Malaysia on 10/6/2017 or nearest suitable date and will leave Malaysia for Dhaka on 26/6/2017 or nearest suitable date.

03. They will submit a report on the training programme to the Security Services Division, Ministry of Home Affairs within seven days of their return.
